## Our May Speaker, Jay Jorgensen, Author and Historian

Topic: The Battle of the Wheatfield at Gettysburg

At 4 pm on July 2, 1863 Robert E. Lee's Army of Northern Virginia began its assault on George Gordon Meade's Army of the Potomac south of the small town of Gettysburg, Pennsylvania. In what General James Longstreet would characterize as "the best three hours' fighting ever done by any troops on any battlefield," Confederate brigades assaulted the Union line repeatedly. General George Anderson's Georgians began the fight for George Rose's Wheatfield by attacking Northern soldiers posted along the southern end of the Wheatfield and the Stoney Hill. The action soon escalated into a bloody slugfest that has accurately been called a "maelstrom of fierce fighting." By nightfall, six Confederate brigades had engaged thirteen Federal brigades. Of the more than 20,000 soldiers involved in the fighting, one out of every three became a casualty. This fighting has long been overlooked, in large part because it was so confusing and there was little, if any, overall leadership of troops in the fighting. This month's presentation will focus on that battle, as our speaker will lead us through the action from beginning to end.

#### Jay Jorgensen

Jay Jorgensen graduated from Fairleigh Dickinson University with a BA in history, from Villanova University School of Law with a JD, and from American Military University with a MA in military history - Civil War Studies. He is a Superior Court Judge in New Jersey. Jay is the author of Gettysburg's Bloody Wheatfield, which won the prestigious Bachelder-Coddington Award for best new book on Gettysburg in 2002. He is also the author of The Wheatfield at Gettysburg: A Walking Tour, Edward Porter Alexander: Confederate Cannoneer, and Gettysburg's Leadership Lessons for Lawyers (and Non-Lawyers too!). Books will be available for purchase and signing at the meeting.


