THE EMANCIPATION PROCLAMATION JANUARY 1, 1863



As the country entered its third year of conflict and more blood flowed, President Lincoln sought to bolster his war-weary Union. On the strength of the victory at Antietam in Fall 1862, on January 1, 1863, Lincoln issued the Emancipation Proclamation stipulating "that all persons held as slaves" within the rebellious states "are, and henceforward shall be free." Despite this broad declaration, the Emancipation Proclamation applied only to the "rebellious states" that had seceded from the Union, leaving slavery untouched in the loyal border states. It also exempted parts of the Confederacy already under Northern control. But, most importantly, the freedom it promised could only be realized if the Union won the war.

While the Proclamation had its share of critics, it captured the hearts and minds of the people and changed the nature of the war from a political struggle to a moral conflict defining the very fabric of the nation. Lincoln was no longer trying to put down a rebellion; the government was now publicly dedicated to ending slavery. The bold declaration also swayed European public opinion in favor of the Union at a crucial time.

As a milestone in the War as well as in the fight for human freedom, the Emancipation Proclamation holds a prominent place among the great documents of our nation.

Ted Brennan and David Bloom of the Third Regiment of Infantry, Maryland Volunteers will present a program focusing on how Union troops were prepared for combat.

Ted and David will discuss what a new recruit faced when he first entered military life during the Civil War and what he was taught in training camp prior to being sent to the front.

The Third Maryland is a Union Living History/Reenactment group dedicated to the men who fought in the conflict, and to preserving the history of the Civil War through educational activities including battle reenactments and living history program.

David Bloom, who has been a reenactor for more than a decade, is a descendant of a Third Maryland soldier and is well-known for his extensive research on all things Third Maryland. David currently serves as a Corporal in the reactivated Third Regiment

Infantry, Maryland Volunteers. In addition to his field duties, he serves as the Unit President and official historian.

After earning BA and Master's degrees in history, David devoted 32 years to government service, including his current position as manager of the Westminster Social Security office.

In keeping with his deeply rooted interest in the Civil War, David is a Founding member of Pipe Creek Civil War Roundtable (Westminster, MD). He has published an article in *Civil War Historian* magazine.

Ted Brennan, also a lifelong Civil War enthusiast, spent his childhood tramping all over Civil War Battlefields with his father and brothers. Ted has been reeneacting for 18 years where he has spent time as a company commander, battalion commander, brigade commander and division commander. He has also served as a staff officer on many occasions. Ted has been responsible for planning and conducting training camps for officers, Non-Commissioned Officers and new recruits using period manuals and training techniques. He currently serves on the Board of Directors for the Cedar Creek Battlefield Foundation.

In his professional life, Ted serves as the Assistant Director of Government Relations for ONE, which is a Non-Governmental Organization founded by U2 Lead Singer, Bono. ONE is dedicated to fighting extreme poverty and disease in the Third World. Ted Earned a BA degree in Government and International Relations from the University of Notre Dame.

The Bookshelf

Death is in the Breeze: Disease during the American Civil War by Bonnie Brice Dorwat, M.D. Illustrated, 12 Appendices, 170 pp., 2009 National Museum of Civil War Medicine, Frederick, MD. Available at the NMCWM Museum Store or www.civilwarmed.org.



With a focus on some of the prevalent illnesses afflicting the soldiers of the time, Dr. Dorwat's book fills a large gap in our understanding of Civil War medicine which tends to explore only battlefield injuries. In fact, military medical officers actually spent little

time treating battle wounds and the majority of time treating diseases such as arthritis and rheumatism. The author also examines the medical education and training of the time, illustrated by the experiences of her great-grandfather, Walter Brice, M.D. *Death is in the Breeze* is one of the most significant books on medical care of the soldiers of the Civil War.

Like a Meteor Blazing Brightly: The Short but Controversial Life of Colonel Ulric Dahlgren by Eric J. Wittenberg. Illustrated, Maps, Bibliography, 318 pp., 2009. Edinborough Press, Roseville, MN.

This biography Adm. John Dahlgren's son, a young colonel who gained lasting fame when he died at age 21 in the disastrous Kilpatrick-Dahlgren raid on Richmond in March 1864, is masterfully written by Eric Wittenberg, the dean of Eastern Theater cavalry operations. The insightful, lively narrative offers a new perspective on the raid and on the Dahlgren papers found on the colonel's body — one of the most fascinating mysteries of the Civil War.



In the News

Gettysburg Casino again on the horizon

After losing his bid for a casino in close proximity to the Gettysburg National Military Park in 2006, local investor/business owner David LeVan has renewed his efforts to bring slots to the edge of the Battlefield. Although he did not intend to reveal his plans for several months, the story broke in local newspapers in late November.

LeVan and his partner, Joseph Lashinger, a former state representative who works in the gaming industry, have a one-year option on the Eisenhower Hotel and Conference Center, less than a mile from the Battlefield. The 100-acre site includes the hotel, residential units and sports complex.

Opponents are reviewing the tactics they used in the heated anti-casino campaign of 2006, but LeVan's success or failure this time around depends largely on the state Legislature which is considering a myriad of issues related to gambling, licensing, and related revenues, including the legalization of table games and whether the tax revenues should benefit schools or be used for property relief. Legislators are also under pressure from Gov. Ed Rendell's warning that hundreds of state jobs will be lost unless a casino-expansion measure passes. Although there has been a downturn in gaming, Pennsylvania slots gambling was in excess of \$20 billion in 2008.

The NoCasino Gettysburg grassroots organization, led by Susan Star Paddock, has reactived as well as the Pro Casino Adams County group.
