FCCWRT members and their guests have been invited to a special program hosted by Chad Baker, director of the new Bjorlee Museum, and featuring Linsay Darnell, a deaf Civil War reenactor who will give us a special presen-

tation on "Deaf Soldiers in the Civil War." Mr. Darnell will discuss both Union and Confederate deaf soldiers, based upon his research of unit records, personal letters and official documents. He will give his program using sign language that will be interpreted for us by a sign language translator. Following Mr. Darnell's talk, Director Baker will give a brief overview of the Bjorlee Museum's displays related to Frederick's history. Look for more details in our March *Banner*.

FCCWRT Wins Grant for Civil War Trails Marker

The FCCWRT was awarded a \$1,300 grant to fund the installation of a Civil War Trails Marker at the approximate location of the Battle of Frederick on July 7 and 8, 1864. The marker will be situated in the parking lot of the Red Horse Restaurant on US 40 (the Golden Mile/Patrick Street), which was a farmer's field during the Civil War.

Speaker: John Reid Park Ranger, Historian Manassas National Battlefield Park

Subject: How the two Battles of Manassas influenced the War

Our Speaker

anassas National Battlefield has the distinction of being the site of two battles of the Civil War — both major battles, both with significant ramifications. Park Ranger and Interpreter John Reid will discuss the two battles of Manassas and their implications for the outcome of the



War. An expert in military history, John has been a park ranger at military parks for 22 years including the past 12 years at Manassas National Battlefield Park.

Both Battles of Manassas, known in Union circles as Bull Run, were crushing defeats for the Union. The 1st Manassas occurred early in the War in July 1861 and was a watershed event that alerted Lincoln and everyone else that this conflict indeed was not going to be over any time soon.

The 2nd Manassas at the end of August 1862, was the culmination of a series of fierce but scattered clashes that came to a head when Lee's forces under Gen. "Stonewall" Jackson raided Union Gen. John Pope's supply depot at Manassas Junction. Beginning August 28, three days of brutal fighting ensued. Jackson's forces held and by nightfall on August 30, the Union Army withdrew.

In both battles, the outnumbered Confederates won victories on Manassas Plain that humiliated and humbled two Union armies, forcing their retreat back toward Washington — and frustrating the Union's hopes of bringing the Confederacy to heel in the region. John will explore the repercussions of these two conflicts and how each was a gamechanger for the course of the War.

Along with his years at Manassas National Battlefield, John has served at military history parks in Morristown, NJ; Fort McHenry, MD; and, Horseshoe Bend, AL. John also is historic weapons supervisor and inspector for the National Park Service, Washington, D.C., and region, and is an NPS-wide instructor in historic weapons safety.

John majored in military history at Norwich University in Vermont. He has published articles on Andrew Jackson and the Creek War of 1814, the battles of Bull Run (or Manassas), and wrote a thesis on the Russian fleet's visit to the Union during the War. He collects military memorabilia, with concentration on World War I. John lives in Columbia with his wife, Ella, and son, John Thomas.

Civil War Medal of Honor Service Remembers Decatur Dorsey

Antietam Camp #3, Sons of Union Veterans of the Civil War, will sponsor a Civil War Medal of Honor Remembrance Service on March 24 at 10 a.m. at the Quinn Chapel of the A.M.E. Church, 106 East 3rd St., Frederick. The service will honor 1st Sgt. Decatur Dorsey – born a slave in Howard County – who was awarded the Medal of Honor for "extraordinary heroism on July 30, 1864,




while serving with Company B, 39th USCT" as color bearer during the Battle of the Crater at Petersburg, VA.

Dorsey enlisted as a private in the US Colored Infantry in March 1864 at age 25 and was quickly promoted to corporal. At the Battle of the Crater, he planted his colors on the Confederate works in advance of his regiment. When his unit was forced to pull back, he retrieved the flag and rallied the men for another charge. Two days later he was promoted to 1st sergeant. Dorsey served to the end of the War and lived to age 55.

The ceremony will include a short worship service, a procession, and honors and taps, followed by an "off the menu" meal at Brewer's Alley. All FCCWRT members and friends are welcome.

The Bookshelf

The Library of Congress Illustrated Timeline of the Civil War, by Margaret E. Wagner. Illustrations, photos, bibliography, notes, index, 254 pp., 2011, Little Brown and Co., New York, NY.



If you plan to buy only one book during the Sesquicentennial, this is the one to buy. Margaret Wagner, senior writer-editor for the Library of Congress Publishing Office, brings the timeline of the Civil War to life, both in pictures and in riveting first-person accounts from journalists, soldiers and nurses, all eyewitnesses


the devastating impact of war.

Much more than a beautiful coffee table book, this is a rare treasure including drafts of Lincoln's speeches in his own handwriting, portraits of soldiers and politicians not found in standard Civil War books, and much more.

Drawing upon the vast resources of the Library of Congress, the author has imaginatively organized the book with more than 350 extraordinary photographs and presented a fascinating day-by-day annotated account of each year of the War that has earned high praise from literary critics and Civil War scholars alike.

My Southern Home or, The South and Its People, by William Wells Brown. Illustrations, notes, index, bibliography, 304 pp., 2011, University of North Carolina Press, Chapel Hill, NC.

Until slave-born William Wells Brown escaped from his owner in 1834 at age 20, his life was like any other slave of the era. But he blossomed into a successful novelist, journalist and playwright, who is considered to be the first African American to write a novel, published in England in 1853. After purchasing his freedom in 1854, Brown returned



to America and became an outspoken abolitionist who lectured widely but was overshadowed by Frederick Douglas, his contemporary.

In this, Brown's final book published in 1880, he writes from the perspective of a freed slave of the stark realities of life in the South with all of its atrocities and injustices. Distinguished professor and author John Ernest offers readers an exceptionally well-edited edition of this work with extensive annotations that clarify Brown's writing, as well as a 35-page scholarly introduction that gives context to Brown's work in terms of its place in American literature as well as its historical significance.

My Southern Home is a revealing study of the South from pre- to post-War and beyond — and is invaluable reading for anyone interested in American history.

According to Patsy Ensminger, Operations Director of the Tourism Council of Frederick County, the Heart of the Civil War Heritage Area Advisory Board voted to approve our grant in "an extremely competitive round" in which requests totaled more than twice the amount available for distribution.


In accordance with the terms of the grant, the total cost of the project is \$2,600 and the FCCWRT will match the balance of the needed funds with a \$1,300 contribution. Additionally, we will fund annual maintenance costs of the marker of \$200. Our share of the funding will be drawn from the income of membership dues and our monthly raffles. We are also planning future community fund-raising activities to replace these funds so we can continue projects promoting a better understanding of Frederick County's Civil War heritage.

The grant will be awarded at our February meeting, and we will present our matching contribution.


This project is being coordinated by Bob Kozak with the able assistance of Jack Sheriff, Gail Stephens and Jim Enright.
